INFORMATION FOR CAT OWNERS:

- Owner must be 18 years of age or older.
- Cats must be **sterilized and microchipped** by 6 months of age.
- Cats must wear a registration tag when in a public place.
- Cats owned by pensioners – Half the fee otherwise payable, (on production of the Pension Concession Card, State Concession Card or a Statutory Declaration quoting the pension number).
- Cats may be impounded if found to be in contravention of the Cat Act 2011.
- Only approved breeders may breed cats.
- Any change in particulars contained in this application including change of ownership, the death of a cat and any change in address **MUST** be notified to Council immediately.
